

Essex Undergraduate Global Partner Scholarships 2025-26

If you're an international student studying at one of our global channel partners, you could be eligible for a tuition fee discount of up to 20% or a scholarship of up to $\pm 1,500$, which will be distributed across your years of study as outlined in the table below.

Terms and conditions

Eligibility

- These scholarships are restricted to students who are assessed to pay overseas fees and are entirely self-funded*.
- Applicants must be studying on a progression link agreement at one of our Global Link institutions listed above to be considered for this award (excluding applicants on the UKT Law programmes with specific partner institutions for which we have a separate scholarship please see <u>Essex Law</u> <u>Global Partners Scholarship T&Cs</u> for eligibility requirements).
- Applicants must meet our standard conditional offer.
- CSCSE students are only eligible for the award with A in one graded component for 3+1 SQA Undergraduate entry in link agreement programme/s.
- The award cannot be held in conjunction with any other University of Essex scholarships.

Successful applicants should be available for promotional activities.

*Students receiving a repayable loan to fund their studies will be considered as self-funded

Students who are not eligible

The following students are NOT eligible for this scholarship regardless of meeting the above criteria:

- University of Essex International College (UEIC) Pathway students.
- Applicants undertaking a degree that is normally delivered wholly online.
- Applicants awarded the scholarship who defer entry to following academic years will be ineligible to receive the award and will be considered in line with the terms and conditions that apply in the new proposed year of entry.
- Applicants who are fully or partly sponsored by their government or other external agency and are not required to make any repayments (this does not include VISA sponsorship)
- Applicants who are assessed as paying home tuition fees.
- Applicants who are awarded the Academic Excellence Senior Status Law Scholarship.
- Current students whose first year of undergraduate study at the University of Essex, was prior to academic year 2025-26.

How to apply

If you meet all the eligibility criteria, you will automatically be considered for this award. You don't need to complete an application form. The University will assess your eligibility based on your country of domicile and fee status that you submit on your application for your place at Essex.

Payment arrangements

- These scholarships will only be made available as a reduction on the tuition fee that is payable on registration at the University. Payment cannot be offset against a tuition fee deposit if one is required.
- If you intermit from your course, you may, at the discretion of the University, be entitled to a prorata payment of the remainder of your award on your return to study. Please contact the <u>Funding</u> <u>Team</u> for further information.

Resolution of disputes

Acceptance of this award constitutes acceptance of these terms and conditions. Applicants should contact the <u>Undergraduate Admissions Team</u> in the first instance for guidance regarding this award. Registered students should contact the <u>Funding Team</u>. In cases not covered by the above terms and conditions, or where a student claims exceptional circumstances, or disputes a decision not to make

payments due under an award, final appeals on decisions regarding eligibility must be made via the <u>Student Complaints process</u>. The Academic Registrar or their nominee will review the case and his/her decision will be final.
